MAS Refresh 30 Clause and Provision Changes

In accordance with E.O. 14275, Restoring Common Sense to Federal Procurement (April 15, 2025), and consistent with the Revolutionary FAR Overhaul, Refresh 30 incorporates GSA deviations that align with the revised regulatory framework. The revisions simplify acquisition requirements, remove non-statutory provisions, and promote the use of plain-language clauses and provisions.
