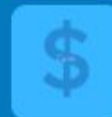

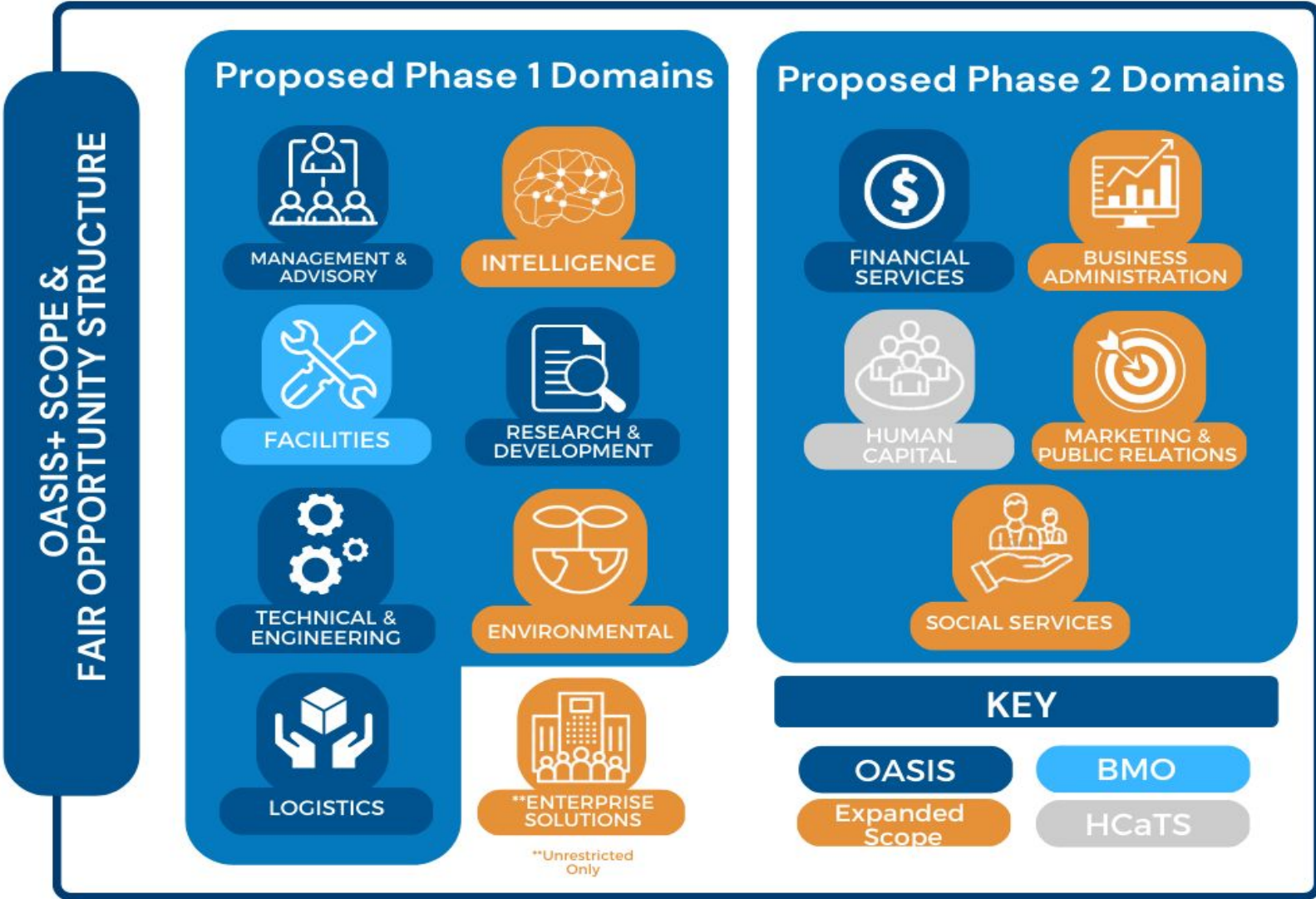

- The Government intends to use the OASIS+ Submission Portal (OSP) for proposal preparation, proposal evaluation, and contract management purposes. Training will be provided to Contractors regarding the use of this system for proposal submission and post award requirements.
- The electronic solicitation documents, as posted on <https://www.SAM.gov>, shall be the "official" documents for this solicitation. In the event of a discrepancy between the electronic solicitation documents, as posted on SAM.gov, and the OSP, the electronic solicitation documents on SAM.gov, shall take precedence.
- The Government will not reimburse Offerors for any cost incurred for the preparation and submission of a proposal in response to this solicitation.

# Section L.5.2.1 - Qualifying Project Definition

---



To be considered a Qualifying Project (QP), each submitted project must meet **all** of the following minimum criteria:

1. Be any of the following:
  - a. A single contract - including prime contracts, subcontracts, and commercial contracts; or
  - b. A single task order awarded under an indefinite delivery task order contract (Definite Quantity, Requirements, or Indefinite Quantity), Blanket Purchase Agreement (BPA), or Basic Ordering Agreement (BOA), including single or multiple award; or
  - c. A task order under a Federal Supply Schedule contract (FAR 8.405-2) or BPA (FAR 8.405-3); or
  - d. An Other Transaction Authority (OTA) award issued under 10 U.S.C. 4021 or other applicable authority; or
  - e. A “Collection of Task Orders” as defined in Section L.5.2.1 (below).
    - i. Offerors are limited to the submission of one (1) “Collection of Task Orders” per Domain submission.

## Section L.5.2.1 - Qualifying Project Definition (cont.)

---



2. Be a contract or order for services as defined in FAR part 37.
3. Meet or exceed a **minimum average annual value** specified within Attachment J.P-1, OASIS+ Domain Qualifications Matrix for each proposed Domain.
4. Be ongoing (with at least six months of completed performance from RFP to closing date) or completed within five years from the date of RFP issuance (June 15, 2023). There is no minimum period of performance for completed projects; **and**
5. Cannot have an associated record of negative past performance (e.g. on a five point scale, average of scores <3.0). See Sections L.5.6 and M.5.6 for more details.

# Note for Socioeconomic RFPs Regarding QPs

---



For award under the OASIS+ 8(a), HUBZone, WOSB, and SDVOSB RFPs

**A minimum of two QPs** must be from a member “similarly situated to the set-aside”.

See example from OASIS+ 8(a) below:

*For award under the OASIS+ 8(a) IDIQ, a minimum of two QPs must be from an SBA-certified 8(a) small business concern. The submitted QPs can be from an 8(a) member of a joint venture, the offering 8(a) joint venture, or a proposed 8(a) subcontractor, as described in Section L.5.1.3.1...*

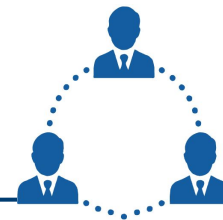

# OASIS+ Evaluation Strategy

---

## From Section M.3 - BASIS FOR AWARDS

- Proposals submitted in response to this solicitation will be awarded credits in accordance with unique Qualifications Matrices for [all proposed] MA-IDIQs.
- Each **Domain** has a specific **Qualifications Matrix** and corresponding qualifying threshold to ensure the minimum standards are representative of customer needs in that mission space.
- To receive a Domain award, the offer must meet or exceed the Domain-specific qualification threshold at Section M.7 through the submission requirements in Section L. Excluding the minimum mandatory submission requirements detailed in Section L.5.1, L.5.7 and L.5.8, the Offeror has the discretion to use any combination of qualifications detailed in the Qualifications Matrix to achieve the qualifying threshold. Offerors that fail to demonstrate a particular qualification will simply not receive credit for that criterion.

- GSA will not be limiting the number of awards under OASIS+
- The basis for awards will be **All Qualified Offerors with a Fair and Reasonable Price**
- Cost/Price will be determined fair and reasonable in accordance with Section M.8

# OASIS+ Domain Qualification Standards

---



- **Qualifying threshold must be met using a combination of project and corporate-level criteria**
  - Majority of credit comes from “Qualifying Projects”
  - Multiple avenues to meet Domain qualification standard
  - Tailored Factors Support Domain’s Critical Mission Scope
  - Offers will be evaluated against an objective standard and threshold for each proposed domain (i.e. qualifying thresholds in Attachment J.P-1), and **will not be evaluated against, or compared to, other offers**
- **Enterprise Solutions Domain (Unrestricted Only)**
  - Mission critical requirements (\$250M+), criteria targets highly qualified technically capable companies to perform specialized and/or complex services
- **Intelligence Domain**
  - Additional credit for cleared facilities and/or personnel

# Acceptability Review and Evaluation Process

---

- All proposals will be evaluated
- The evaluation team will initially verify that the proposal meets all of the acceptability review requirements in Section M.5 of the solicitation
- The evaluation team will evaluate and verify the proposal's supporting documentation for each evaluation element
- If the proposal does not meet or exceed the Domain Qualification Threshold, the evaluation for that proposal will stop, and the Offeror will be eliminated from further consideration for award
